**“ A RESOLUTION
 GRANTING EQUIVALENCE TO SOLDIER’S
 CANDIDATE COURSE AND BASIC MILITARY COURSE OF THE AFP AS
 EQUIVALENT AS THE PUBLIC SAFETY BASIC RECRUIT COURSE”.**

WHEREAS, upon the passage of RA 6975 (DILG Act of 1990), several members of the Armed Forces of the Philippines (AFP), more particularly those that came from the defunct Philippine Constabulary/Integrated National Police (PC/INP) were absorbed into the new Philippine National Police (PNP);

WHEREAS, majority of those AFP personnel that were absorbed in the PNP as Police Non-Commissioned Officer (PNCO), more particularly those holding the ranks of Police Officer I to Police Officer II, have completed their Soldier’s Candidate Course and AFP Basic Military Course upon entering in the service;

WHEREAS, it is unfortunate that for lack of the required Public Safety Basic Recruit Course (PSBRC), a mandatory training in the PNP service, the afore-mentioned PNP uniformed personnel were disqualified for promotion to Senior Police Officer;

WHEREAS, upon evaluation of the subjects in the Program of Instruction (POI) of the Soldier’s Candidate Course and Basic Military Course the said courses were found to be equivalent to PSBRC.;


WHEREAS, to level the playing fields for those PNP absorbee’s that came from the ranks of the AFP particularly the PC/INP and for the reasons that the afore-mentioned courses bears substantial similarity it is, therefore, imperative that immediate board action be taken to address the situation.


WHEREFORE, the Board resolved as it is hereby resolved to grant equivalence to SOLDIER’S CANDIDATE COURSE and BASIC MILITARY COURSE as the PUBLIC SAFETY BASIC RECRUIT COURSE provided that the same had been completed not later than October 1, 1993.






