 (PPSC) COURSE OFFERINGS".**


**WHEREAS,** To accommodate **Senior Non-Commissioned Police Officers** who have been promoted to Inspector Ranks in a temporary status, the Philippine Public Safety College (PPSC) offered **Public Safety Inspectors Course (PSIC)** as an alternate course to offset the mandatory Public Safety Officers Candidate Course (PSOCC) requirement for promotion purposes.


**WHEREAS,** The Philippine National Police (PNP) has discontinued promoting Police Officers to the rank of Inspectors without undergoing the mandatory Public Safety Officers Candidate Course (PSOCC) to ensure that those who will be promoted shall possess the necessary training and educational qualifications required to aptly perform their duties, functions and responsibilities effectively and efficiently based on the set standard.






