**"A RESOLUTION
RENAMING PUBLIC SAFETY CRIME INVESTIGATION AND DETECTION
COURSE (PS CRIDEC) TO PUBLIC SAFETY INVESTIGATION AND
DETECTION COURSE (PS IDC) UNDER THE CRIME INVESTIGATION AND
DETECTION COURSE (CRIDEC) PROGRAM, AND ADJUSTING THE
DURATION FROM 4 ½ TO 5 ½ MONTHS".**

WHEREAS, Under the CRIDEC Program of HER EXCELLENCY GLORIA MACAPAGAL ARROYO, consisting of three investigative courses namely: the PS CRIDEC, PS NIC and PS TIC, innovations on curriculum were made thereby renaming the PS CRIDEC to PS IDC while the titles of the other two are retained;

WHEREAS, The Program of Instruction (POI) for the three (3) courses were modified to include all the subjects of the Criminal Investigation and Detective Development Course (CIDDC) and the subjects under the leadership module of both the Junior Leadership and Senior Leadership Courses in each of the three (3) Public Safety Investigative Courses;


WHEREAS, The duration in the conduct of these mandatory training courses were also adjusted from four and a half (4 ½) to five and a half (5 ½) months to make each course more comprehensive for the student investigators.




